Mardi Gras Parade Street Closures

Arlington County Police will close Wilson Blvd. in the Courthouse and Clarendon neighborhoods on Tuesday March 8, 2011, for the Clarendon Alliance Mardi Gras Parade.

Wilson Blvd. from Veitch St. to Barton St. will be closed from 6:45pm to 9:30pm. Wilson Blvd. from Barton St. to Irving St. will be closed from 7:30pm to 9:30pm. Adams St sand Wayne St., between Clarendon Blvd. and Wilson Blvd., will be closed from 6:45pm to 8:00pm. In addition, street parking in the area will be restricted. Motorists should look for temporary "No Parking" signs. Illegally parked vehicles may be ticketed or towed.

We will discuss the threats and trends that will impact Clarendon, Courthouse, and Arlington in the next 10 years.

Terry Holzheimer, the county's Director of Economic Development, will provide the county staff's perspective on:

- Whether the arrival of Crumbs and Trader Joe's signals a shift in Clarendon's retail growth from bars to higher value and more diverse retail
- Competition with Tysons for businesses once Metro is extended
- The economic impact of defense and defense contractor relocations from Crystal City
- Population, traffic, home value and demographic changes

A Shade Canopy at LV Park?

Do you find the sun oppressive in the spring/summer/fall while sitting in or around the sandbox at the LV Park? Do you wish there were more places to find shade besides the (now complete!) pavilion roof? Then we need your support (with your votes and dollars) to help us fundraise for a shade canopy for the sandbox area at the Lyon Village Park.

For financial reasons, the county cannot afford it, so the LVCA Executive Committee has agreed to try to raise the necessary funds — about \$8,000, including installation. The county has generously agreed to provide up to 12 hours per year of maintenance and wintertime storage for the canopy, but any significant repairs or maintenance would be an ongoing cost for our community.

We are looking for your thoughts and feedback at the March 14th Lyon Village General Meeting. We will provide further details about shortand longer-term cost implications, plus vote on whether to proceed.

Nominate a Stretch of Missing Sidewalk for Funding

Whether you are briskly walking to the Metro, or strolling through our bucolic neighborhood, our sidewalks are the bridges that connect neighbors within our community. You may have noticed that some of our sidewalks end abruptly, or don't exist at all, making it difficult for pedestrians, strollers, and dogs to pass. All is not lost! Arlington County's Neighborhood Conservation Program could help!

The program brings citizens together to help plan their communities. One of the funded initiatives of the NCP is a "Missing Links" program. If you have a stretch of missing sidewalk (up to three properties) in front of your house, on your street, or that you have noticed in the neighborhood, please contact Shelly Snook, our Neighborhood Conservation rep at mcsnooks@aol.com. We would like to solicit as many potential projects as we can, and then can request funding for one project per year to make our neighborhood more walkable. Funding requires that at least 60% of the effected homes are amenable to the improvements. Sidewalks are installed on county, not personal, property.

Monitoring Construction

Recently we have received a number of complaints from neighbors about the impact some of the construction practices have had on nearby properties, streets, and sidewalks. For example, we have had to work closely with county staff and the Views Project contractor to keep construction trucks off LV streets north of 13th Street. Contractors are required to be careful about how their projects impact the neighborhood. If you spot unsafe or otherwise inappropriate actions by contractors, please email <u>GJCarten@verizon.net</u>. Date, time, location, truck name, license tag, and pictures are all helpful in documenting improper activity. Should you spot any unsafe conditions and need an immediate response, call the county's non-emergency phone number at 703-558-2222.

Trader Joe's Update

The developer is finalizing the lease with Trader Joe's, with expected opening this summer. The rest of the Clarendon Center retail spaces have been fully leased. The apartments above are 80% rented.

Pedestrian Safety Tips

Pedestrian Responsibilities:

Although the pedestrian clearly has the right-of-way, one should not throw caution to the wind by not accepting any responsibility for your own safety. The pedestrian must look both ways before attempting to cross a street and all crossings should be made in crosswalks. Crossing a street in the middle of a block where there is no designated crosswalk is not recommended.

The pedestrian has a responsibility to be considerate of the driver who has complied with the law and yielded the right-of-way. Cross the street as expeditiously as possible.

Drivers' Responsibilities: Yield to pedestrians ... It's the law!

Safety Tips

Look both ways before stepping off a curb.

If walking where there is no sidewalk, always walk facing oncoming traffic.

If walking at night, wear light-colored clothing or attach reflective tape to clothing so you are more visible to drivers.

Be aware that drivers may be blinded by sunlight or the headlights of oncoming traffic. Never assume that a driver sees you!

When walking with children, always grasp their hands firmly to ensure they don't break away and dart into traffic.
