### Elementary School Boundary Process Begins

At the January 23 work session, the Arlington School Board began the process of considering elementary school boundaries. The process could result in changing a neighborhood school (e.g., Arlington Science Focus and Taylor) to an option school site (e.g., Key Immersion or Arlington Traditional School) or vice versa.

Taking into account projections for student enrollment for the next 10 years, and the new elementary schools that will be opening between 2019 and 2021, the School Board is now reassessing the location of elementary schools. APS hopes to make better use of its resources by placing neighborhood schools closer to where large numbers of students live. In this process, the School Board will consider efficiency, proximity, stability, alignment, demographics, and contiguity.

In February, the School Board plans to finalize its communications and community outreach plan. In mid- to late- February, APS will conduct its initial community meeting and plans to continue to engage with the Community through October 2018. In November 2018, the Superintendent plans to recommend boundary changes for adoption by the School Board. All boundaries should be finalized by January 2019 and any whole-school moves will take place in the summer of 2020 or 2021.

## Cornhole Tournament, February 24

Arlington Cornhole and the Lyon Village Citizens Association will be hosting a cornhole tournament, Saturday, February 24. Benefits will go toward remodeling the Lyon Village Community Home.

The tournament will be held at Community House. Check in will begin at 2:30pm and games will begin at 3pm. Boards will be set up as of 2:30 for participants who want to come early and throw some bags socially. The entrance fee is \$30 for a team of 2 (that's \$15 each, but you register as one team, not individually).

There will be 5 boards going for tournament games through the end of the first round of games; then we will begin opening up boards for social games until the end of the event. Beer, wine, and food will be available there, but are not included with the registration fee. If the field fills up to our capacity, the winning team will win somewhere north of \$400, second place over \$100, and we'll raise over \$1,000 for the renovation of the Community House.

### Market Common Approval

Board approved a plan to redevelop an existing office building on Wilson Boulevard in the heart of Clarendon. Under the proposal, the IOTA and A & R Engravers buildings would be incorporated into the existing site plan for the Clarendon Education Center building.

The building would be expanded by adding a fourth floor, with outdoor terraces, across the two properties. Developer Clarendon Regency IV, LLC plans to preserve the historic Engravers Building at 2836 Wilson Blvd.

The redevelopment also would reconfigure the corner plaza's retail space at the intersection of Clarendon Blvd. and N. Edgewood Street, and create a recessed arcade space along N. Edgewood Street. Wilson Blvd.'s streetscape would be reconfigured, with tree pits relocated into parking lane bump-outs, to create a wider sidewalk.
