### LVCA General Meeting, April 17

### Pat Miller Memorial Service, April 11

Long-time Lyon Village resident Pat Miller died on March 28 at Powhatan Nursing Home in Falls Church. She was 98. Pat was an active volunteer in the neighborhood for countless years, most notably as a member of the Lyon Village Women's Club. During her tenure, the Club paid off the mortgage on the Community House, through numerous fundraisers and rental fees. She served as a member of the board of the Community House and delivered the LVCA newsletter for over a decade. A veteran of the Foreign Service, she always referred to the neighborhood as "The Village." It was dear to her heart. A memorial service will be held at 1:00pm on April 11 at Charles Wesley Methodist Church in McLean.

### ECARE, April 15

The Environmental Collection and Recycling Event (ECARE) is coming up on Saturday, April 15, from 8:30am - 3pm, at the west parking lot of Thomas Jefferson Middle School. The county will be accepting household hazardous waste, scrap metal, and obsolescent electronics. Several non-profits will also be participating, including Bikes for the World, which will be accepting bicycles, bike parts, wrenches, and portable sewing machines.

For those Lyon Village residents unable to come who have items they wish to recycle or dispose of environmentally, Keith Oberg ([keithoberg@gmail.com](mailto:keithoberg@gmail.com)) is willing to accept and deliver two small items qualifying for free County disposal, in exchange for donating a bike and \$10, or \$10 alone, to Bikes for the World.

He would also provide a receipt good for tax purposes to the donor for the value of bike (or other items accepted by Bikes for the World) and financial donation.

### Clarendon UMC Events, April 16 and 23

Clarendon UMC (606 N. Irving, Arlington) will hold three worship services, an egg hunt, and breakfast on Easter Sunday, April 16. There will be a sunrise service at 6:30am, a Contemporary service at 8:30am, followed by a breakfast buffet, an egg hunt on the lawn at 10am, and a traditional service at 11am. All are welcome.

The following Sunday evening on April 23 at 7:00 pm, Clarendon will hold its annual Easter Portion (Part II and III) of Handel's Messiah as a sing-a-long. This includes the Hallelujah Chorus. A reception follows in Corry Fellowship Hall. The church is handicapped accessible and nursery care is provided. ## General Meeting, April 17, 8pm Community House

James Lander, a member of the Arlington County School Board, will be our guest at the meeting to address a range of school issues. This is a great opportunity for at least one parent to attend and learn more first-hand about upcoming school decisions that will affect Lyon Village. Below are some of the issues under consideration now.

Arlington Public Schools (APS) is proposing a number of changes that will impact LV families, including eliminating the Team (meaning Arlington Science Focus will simply be a neighborhood school without a lottery), and changing Key School from a neighborhood school into a countywide lottery school (meaning those LV families in the Key/ASF boundary would no longer be guaranteed admission to Key, and ASF would be the only neighborhood school for those families). The immediate result of these changes will likely be increased enrollment at ASF due to the kids in the neighborhood zone who do not win the Key lottery, and likely a boundary change down the road to address these additional students. Given that boundary changes are likely, this would seem to be a good opportunity to lobby to bring all of LV together into one neighborhood school zone (almost all of LV is within the ASF one-mile walkzone). These changes would take place in the Fall of 2018.

In addition to these proposals, APS is also making recommendations on where to put an additional 1,300 high school seats. One of the high school proposals would be a new 1,300 seat-facility at the Ed Center (APS office building next to the Planetarium), which would greatly increase the size of Washington-Lee (and likely make participation in sports, music and theater, among others, much more challenging).

APS staff is scheduled to make a recommendation on the elementary school issues April 19 and the School Board will vote on them in June. The School Board is also expected to make a decision on the high schools in June as well. Just a reminder also that next fall APS will tackle boundary changes for the new middle school at the Stratford site (currently home to HB) set to open in 2019.

### Thefts from Parked Cars Continue

Two people were arrested recently after an alert neighbor spotted them entering unlocked parked cars. These incidents have taken place in Lyon Village and in many other parts of the county this year. Here are some simple tips to help reduce the thefts:

1. No matter if you park on a public street, in a driveway or garage take all valuables out of your vehicle. This includes keys, key fobs, purses, cash, credit cards and electronics. Don't forget the valet key that comes with some vehicles.
2. Lock your doors and pull on the door handle to verify it's locked. If a thief can get into a vehicle, he/she can also have access to a garage door opener and can gain access to your home. Always ensure the door between your garage and home is locked.
3. Call police if you see people looking into vehicles. The telltale sign that this has occurred in your neighborhood are open doors with the interior dome lights on. If you don't see the perpetrator(s) but suspect some vehicles have been entered, call the non-emergency number at 703-558-2222. If you see a suspect in your vehicle, DO NOT APPROACH THEM and call 911 immediately.

### Operation Fire Safe

Through October 7, crews from Arlington County Fire Department, Fire Station 4 (Clarendon), will be out every Saturday in neighborhoods conducting a door-to-door survey of home smoke alarms. This initiative, Operation Fire Safe, is entirely voluntary. However, we hope that you will join us in our effort to try and safeguard your families and community.

The targeted initiative attempts to reduce the number of civilian fire fatalities and injuries by ensuring all residents in Arlington County have working smoke alarms. Fire Department personnel will offer free smoke alarm inspections, smoke alarm installations, home fire safety checks and general fire safety education.

### Street Sweeping Starts April 10

Street sweeping removes accumulated debris and pollutants such as sand, salt, metals, petroleum products and bacteria before they wash into streams, the Potomac River and Chesapeake Bay. Arlington's 59 civic associations have been grouped into 11 street sweeping zones. Tips for residents:

- Please try to move your cars from the street when your neighborhood is scheduled to be swept. This ensures that the street sweepers can be more effective.
- If you see a hanging tree limb by a curb and are able to safely remove it, please do so. This helps the sweepers clean the curb.

### Save Iota

A campaign to save the IOTA Club and Cafe is gaining support, but organizers said there's still much uncertainty about the redevelopment plan for IOTA's building.

Organizers of the "Save IOTA" campaign - local residents and IOTA regulars Harry Blackwood and Melissa Mannon - said the lack of public, detailed plans from the developer is making them nervous.

Already, the pair launched a Facebook page for their efforts and have circulated paper petitions at the venue, in addition to an online petition.

A community meeting to discuss the redevelopment of a group of buildings on the 2800 block of Clarendon and Wilson Blvds. by Regency Centers has been rescheduled from March 29 to May 10.
